OTHER TERMS AND CONDITIONS FOR SR/JR/TUTOR

1. The appointment /engagement will be for one year tenure basis subject to Satisfactory performance and on need basis extendable up to for a period of 3 years under Residency scheme for Senior Residents.
2. The appointment /engagement will be for one year tenure basis extendable every year for a period of 3 years subject to satisfactory performance and on need basis FOR (Tutors) NON-CLINICAL DEPARTMENTS under Residency scheme for Junior Residents.
3. The appointment /engagement will be for one year on tenure basis for CLINICAL DEPARTMENTS under RESIDENCY SCHEME for JUNIOR RESIDENTS.
4. Rules of Reservation will be implemented as per Govt of India Instruction.
5. The Appointment shall not confer any right or preference for regular appointment.

20. The absence from work for a period of fifteen days without proper permission of the competent authority will amount to voluntary abandonment of engagement and automatic termination.
21. They will also be required to attend emergency and floor duty and other clinical duty as assigned by the Medical Superintendent or his/her subordinate authority authorized.
