How to apply: The eligible candidates, along with their application filled properly in prescribed proforma should appear for a walk-in-interview on the scheduled date & time. They should also bring two recent passport size photographs along with one set of attested photocopies and originals of testimonials.

EMOLUMENTS:

- Initial Pay Rs.9300/- plus Grade Pay-Rs.4200/- in the PB 2 – (9300-34800) as per CCS (Revised) Pay Rules 2008. DA, HRA & TA as are applicable as per rules.
- **Private practice of any kind will not be allowed.**

TERMS AND CONDITIONS

1. Only Indian Nationals are eligible to apply.
2. Mere submission of application does not confer any right on the candidate to be interviewed.
3. The appointment /engagement will be for one year tenure basis subject to Satisfactory performance and on need basis extendable every year annually for a period of Maximum 3 years in total. **As it is a contractual engagement, no increment will be allowed for extended year of contract.**
4. The Official so engaged should perform any work assigned by the competent authority.
5. Rules of Reservation will be implemented as per Govt of India Instruction.
6. The Appointment shall not confer any right or preference for regular appointment.
7. No claim for any service benefit like, PF, Pension, Gratuity, Medical allowance, Medical Benefit, Seniority, Promotion, encashment, LTC and leave will be admissible.
8. Candidates in the Government Service should submit "No Objection Certificate from the employer at the time of interview
9. NO TA/DA will be admissible for interview or joining.
10. No Accommodation is provided by ESIC for Contractual engagements
11. ESI Corporation may increase or decrease or cancel filling up of the post without assigning any reason at the discretion of the Appointing Authority.
12. All candidates are directed to report for interview at the mentioned time and registered themselves.
13. The Candidate claiming reservation/age relaxation on grounds of belonging to SC/ST/OBC should submit the Valid community Certificate Government of India Prescribed format. OBC Certificate should be in **Annexure "A"** prescribed vide Govt. of India, Department of Personnel and Training O.M No 36036/2/2013-Estt.(Res.), dated 30.05.2014 failing which the benefit of reservation/relaxation will not be given and their application shall be rejected and no request/correspondence will be entertained. **Certificates issued in other formats will not be accepted.**
14. The Candidate at any time found guilty of any gross misconduct or negligence of his/her duties shall be terminated without any notice or payment in lieu of notice period.
15. The absence from work for a period of fifteen days without proper permission of the competent authority will amount to voluntary abandonment of engagement and automatic termination.
16. The Official entitled to avail casual leave which will be computed at prorata basis of one day per month. No other (EL/HPL/Medical/Maternity) leave will be eligible.
