#### GENERAL TERMS AND CONDITIONS

- 1. **SCOPE OF WORK:** This work involves Disposal of Bio-Medical Waste on daily basis according to Bio-Medical Waste Management Act 2016 for ESIC Hospital, K.K.Nagar, Chennai which is a 460 bedded hospital.
- 2. **ELIGIBILITY:** The Tenderer should have at least 3 years' experience in required field as on date of opening of tender. Documentary evidence to be submitted in support thereof with the tender along with their address & contact number.
- 3. **PERIOD OF CONTRACT**: The contract shall be for a period of Two years.
- 4. **RESPONSIBILITY FOR EXECUTING CONTRACT:** The contractor is to be entirely responsible for the execution of the contract in all respects in accordance with the terms and conditions as specified in the acceptance of tender.
- 5. The contractor shall not sublet transfer or assign the contract to any part thereof without the written permission of the Dean. In the event of the contractor contravening this condition, Dean is entitled to place the contract elsewhere on the contractors account at his risk of cost and the contractor shall be liable for any loss or damage, which the Dean, ESIC Hospital, K.K.Nagar, Chennai, may sustain in consequence or arising out of such replacing of the contract.
- 6. EARNEST MONEY DEPOSIT: The Tenderer shall have to deposit Rs.10,000/- as earnest money with their tender, failing which the tender is liable to be rejected. The earnest money is to be paid by Demand Draft drawn in favor of "ESI Fund Account No.1", payable at Chennai. NO CHEQUE WILL BE ACCEPTED. In the event of the withdrawal / revocation of tenders before the date specified for acceptance, the earnest money shall stands forfeited.
- 7. **SECURITY DEPOSIT:** The successful tenderer should remit **10% of the total contract value** in the form of **Bank Guarantee** or **Demand Draft** drawn in favor of **"ESI Fund Account No.1"**, payable at Chennai valid within 15 days from the award of contract. Security Deposit shall be kept valid for a period of 60 days beyond completion of all the contractual obligations in the prescribed format. The security deposit can be forfeited by order of this Institute in the event of any breach or negligence or non-observance of any condition of contract or for unsatisfactory performance or non-

- observance of any condition of the contract. Performance Security will be discharged after completion of contractor's performance obligations under the contract.
- 8. The tenderer should have registered with GST / other statutory document as applicable and produce attested copies of such certificates along with the tender papers, failing which the tender shall liable to be rejected
- 9. **ASSISTANCE TO CONTRACTOR:** The Tenderer shall not be entitled to assistance either, in the supply of raw materials required for the fulfillment of the contract or in the securing of transport facilities.
- 10. The Tenderer should have a permanent place of business in Chennai and the complete Postal Address, Telephone / Mobile / Fax / E-mail address, etc. should be provided, while submitting the completed tender form.
- 11.In the event of any violation of laws, rules, statutory provisions by the contractor, this will amount to breach of contract and in such case, the hospital will have the right for terminating the contract, forthwith, without giving any notice or assigning any reason.
- 12. VALIDITY OF CONTRACT: The contract, if awarded, shall be initially for two years from the date of award subject to continuous satisfactory performance. However, on failure on any aspect by the contractor, the hospital will have the right to terminate the contract forthwith in addition to forfeiting the performance security amount deposited by the contractor and initiating administrative actions for black listing, etc. solely at the discretion of the hospital authority. This period of one year can be further extended to a maximum of one more year, at the sole discretion of the hospital without prejudice to any other right of the hospital.
- 13. The rate shall be quoted for items mentioned in Annexure-VI inclusive of all taxes. The rate once accepted by the hospital shall remain unaltered throughout the period of contract, including any extended period.
- 14. Payment shall be made every month after submission of original invoice & certification from the Infection Control officer.
- 15.**PENALTY:** The contractor shall be responsible for disposal of Bio-Medical Waste in the premises of ESIC Hospital, Chennai daily or within the maximum time of 48 hrs. A penalty of about **10% of work value** will be imposed if there is delay in delivering the

- service, which will be recovered from contractor's bill for unsatisfactory performance of work, as determined by the Dean. The decision of Dean will be final in this regard.
- 16. The bidder shall provide a list of major Government and Private Institutions where its relevant bid item has been supplied during last one year.
- 17.Dean, ESIC Hospital K.K.Nagar, Chennai, does not pledge himself to accept the lowest or any tender and reserve to himself the right of accepting the tender as a whole and selected bidder shall execute the work at the rate quoted by him.
- 18. In case any difference or dispute arise in connection with this tender, all legal proceedings relating to the matter shall be instituted in the court within the jurisdiction of the Chennai.
- 19. Any attempt on the part of the tenderer or their agents to influence the departments in their favor by personal canvassing with the officers concerned will disqualify the tenders.
- 20. Tenderer should be prepared to accept orders subject to the penalty clause for forfeiture of security deposit in the event of default in transportation or failure to disposal within the stipulated period.
- 21. The Contractor should be willing to render their assistance round the clock including holidays/to be able to contact them at any time in case of emergencies.
- 22. Tenders will be opened at Dean's Cell, ESIC Hospital, K.K.Nagar, Chennai-78, on the stipulated date and time in the presence of the tenderers / representatives who choose to be present.

#### PROCEDURE FOR SUBMISSION OF TENDERS /BIDS:

3The bidder must have adequate experience of execution of similar work in Govt. offices/ PSUs / Autonomous Bodies and other similar organizations. #### **SPECIAL TERMS & CONDITIONS**

#### 1. QUALIFICATION:

- The tenderer should be a **Government approved agency** registered with the concerned State Authority i.e, **Tamilnadu Pollution Control Board**, The tenderer will have to submit the following **documents duly self-attested.**
- Photocopy of the Valid License for the disposal of Bio-medical waste from hospitals as per Bio-medical waste Management Rules 2016, Government of India under Environmental Protection Act 1986 from Tamilnadu Pollution Control Board.
- The agency must have set up a Common off-site Bio-medical waste treatment facility for Chennai in accordance with the standards prescribed in the Biomedical Waste Management rules 2016 by Government of India.

#### 2. BIO-MEDICAL WASTE:

- ESIC Hospital, K.K. Nagar Chennai 78 is a 460 bedded multi super-specialty hospital engaged in the services of providing various types of healthcare treatment facilities to its beneficiaries and generates biomedical waste as defined under Biomedical waste management rules 2016 Govt. of India/ Government of Tamilnadu.
- The hospital will segregate the Bio-Medical Wastes as per guidelines, inside the campus, store such segregated wastes in designated color coded containers/bags prior to collection, transportation, treatment and final disposal by the agency.
- The hospital will also label the containers / bags as per guidelines.
- The approved agency shall collect the Bio-medical wastes from the hospital on daily basis at a specified time to suit the convenience of the collection mechanism.
- The agency should make arrangements for collection, transportation, treatment and final disposal of such Bio-medical waste as per norms of Tamilnadu Pollution Control Board.

- The hospital will permit only duly authorized persons with valid Identity Card issued by the agency during mutually agreed time to inspect and collect the waste from the storage premises meant for the same.
- The agency should maintain proper records of the details of the Bio-medical waste collected and also acknowledge the amount of waste handed over and other relevant details in the Hospital Records and registers.

#### 3. ACCEPTANCE OF THE TENDER:

- The criteria for awarding contract will be fulfillment of Technical conditions as well as offering of the lowest rates quoted per kg of biomedical waste.
- Acceptance of the tender of the technically qualified tenderer will normally be on the basis of minimum rate per kg of biomedical waste quoted by the tenderer. The supplier will be paid taxes as applicable.

#### 4. AGREEMENT:

• The successful tenderer would be required to execute contract for Bio-Medical Waste Management as per Government rule with the Dean ESIC Medical College & Hospital, KK Nagar, Chennai – 78 on Non-judicial Stamp Paper(s) worth Rs100/- each and the cost of the same will be borne by the Tenderer only. The terms & conditions of the tender will be part and parcel of the agreement. This agreement will conclude the contract and be enforceable in law.

#### **5. RESPONSIBILITY OF THE AGENCY:**

- The contact person should be available round the clock over phone.
- All the representatives of the agency should be issued valid identity card.
- While it is the responsibility of ESIC Hospital to segregate, label and store the
  Bio-medical waste, subsequent collection, transport and final disposal of all the
  Bio-medical wastes as per government guidelines, the entire responsibility lies
  with the agency only. ESIC will not be responsible for any consequences arising
  out of deficiency from the point of collection.

- The licenses and other relevant documents should be periodically renewed as and when required during the entire contract period. It is subject to verification by the Dean if he so desires.
- The collection of wastes should be on daily basis including holidays. All the guidelines by the government departments should be strictly complied with. The Successful Tenderer shall also provide the name and mobile number of a key person, who can be contacted at any time, even beyond the office hours on holidays. The person should be capable of making arrangement for disposal even on short notice to ESIC Hospital, K.K.Nagar, Chennai.
- The motor vehicles used for the transport of the biomedical waste should also have the mandatory clearance from the appropriate authorities apart from the Motor Vehicle Inspector.
- Relevant records should be maintained and the agency should also cooperate with the hospital authorities in maintaining the relevant registers for biomedical waste in the hospital.
- The Agency should impart appropriate training to its own representatives in handling the biomedical waste. Also training regarding safety measures in handling of biomedical waste should be given to personnel handling such wastes including housekeeping staff of ESIC hospital.
- No article should be supplied to the hospital except on requisition in writing signed by the Dean or by an officer authorized by him/her in writing to do so.

#### **6. INSPECTION OF THE PREMISES:**

• The Dean or his/her authorized representative reserves the right to inspect the offsite premises and disposal methods as and when he/she desires.
